

FOOD & BEVERAGE

The Blackburn Community Centre provides full Food & Beverage service with a wide variety of menu selections to please any of your culinary dreams! Our team can easily accommodate most dietary restrictions such as gluten-free, dairy-free, vegan & vegetarian. Please see separate Food & Beverage PDF for Platter menus, Buffet menus and Beverage Service menus.

Please note that the BCC offers full Bartending and Beverage Service, however, the facility is not fully-licensed, therefore the Bride & Groom must obtain a Special Event Permit to serve alcohol. The S.E.P is done online and has a \$25 associated fee. Please refer to the Food & Beverage PDF for details.





FREQUENTLY ASKED QUESTIONS

DO YOU REQUIRE A DEPOSIT AND WHAT IS IT USED FOR?

We require an initial \$800-Reception Deposit & \$400-Ceremony Deposit (whichever is applicable) to reserve any specific dates or times. A secondary \$1000 Reception (only) Deposit is due 6 months prior to your event date. Deposits are strictly non-refundable and non-transferable to other dates/services. However, deposits are a credit towards your final amount owing!

WHEN IS THE FINAL PAYMENT DUE?

15 days prior to your event 100% of the estimated balance owing is due. This will be the total estimated charges for all Venue Fees, Food and confirmed Beverage, less any deposit(s). At this time, an electronic Credit Card Authorization is collected to process the final amount owing on the day of your event.

IS THERE A MINIMUM NUMBER OF PEOPLE THAT IS REQUIRED TO BOOK THE VENUE?

The Blackburn Community Centre requires a minimum number of 100 attendees (May through October) and a minimum of 75 attendees (November through April) to book the venue on Friday, Saturday, or Sunday. Weekday bookings minimum charge of 50 people. If group is under this minimum number, attrition will apply and will be charged to the Host/Main Bill as a Food & Beverage Fee.

WHAT HAPPENS IF IT RAINS ON OUR WEDDING DAY?

In most cases, if you have a Reception booked with the Blackburn Community Centre, you may use the venue as an <u>impromptu</u> ceremony area!

Or you are more than welcome to rent a tent for the ceremony site, within your contracted ceremony times.

We can assist you with tent rental companies that are accustomed to setting up tents on our properties if it is needed.

IS OUR CEREMONY AREA PRIVATE?

We are a property with many surrounding public areas. We do our best to ensure that only Wedding Guests are in the ceremony areas, however, we cannot always deter curious on-lookers. We strive to keep on-lookers at a reasonable distance from the ceremony areas while your vows are being conducted.

CAN WE PROVIDE OUR OWN FOOD & NON-ALCOHOLIC BEVERAGES?

All food and non-alcoholic beverages are provided and served by the Blackburn Community Centre.

No outside food or non-alcoholic beverage is permitted other than Wedding Cake/Cupcakes, Candy Stations or Wedding Favours.

IS THE BLACKBURN COMMUNITY CENTRE LICSENSED TO SERVE ALCOHOL?

No, the BCC is NOT licensed to serve alcohol. Any event wishing to offer alcoholic bar beverage service must obtain a Special Event Permit. The S.E.P is done online and has a \$25 associated fee. Please refer to the Food & Beverage/S.E.P PDF for details. In accordance with the S.E.P, the Bride & Groom must purchase all alcohol for the event. The BCC Event Coordinator can assist with suggested quantities to make the process a breeze!

DO WE HAVE TO PROVIDE A BARTENDER AND OTHER BAR SUPPLIES?

No! Once you have obtained the S.E.P and purchased the alcohol, the BCC Service Team will take it from there! We provide all S.I.R certified bartender(s), bar supplies, glassware, beverage mix, garnish, ice and refrigeration.

A corkage per beverage served will apply and pricing/minimum spend is noted in the Food & Beverage PDF.

DOES THIS MEAN WE HAVE TO PAY FOR ALL OF THE ALCOHOLIC BEVERAGES CONSUMED AT THE EVENT?

Nope! We can collect cash payment at the bar and will apply that as a credit towards your final amount owing. The price per beverage may be determined by the Bride & Groom, however, the S.E.P. does have a maximum amount that can be charged per specific beverage. Typically, the corkage fee plus the cost of the product purchased (by the B&G) does not total to more than the maximum amount you are able to charge for each beverage at the bar (based on standard beer and spirit pricing).

CAN WE STILL HAVE DINNER WINE SERVICE?

You sure can! Once you have obtained the S.E.P and purchased the Wine, the BCC Service Team will take it from there! We provide all wine glassware, glassware set up, wine service staff, clearing, cleaning, etc. A corkage per bottled served will apply and pricing (no minimum spend for this service) is noted in the Food & Beverage PDF. Please note if you choose to serve

Northern Lights Winery Wines, we offer a 20%-40% case discount on Wine purchased and a lower corkage fee per bottle!!

IS THERE A SOUND SYSTEM AVAILABLE?

We offer a complimentary sound system for Ceremonies and Receptions! The system comes with a wireless, hand-held microphone and Bluetooth or USB hookups. You are responsible for your own music, playlists and music coordinator.

WHAT IS A SOCAN FEE?

A SOCAN (Society of Composers, Authors and Music Publishers of Canada) Fee is a government charge collected by establishments that offer music and dancing for events such as weddings. This fee is remitted to the SOCAN association by BCC and the client is not required to take any further action.

ARE THE WEDDING GROUNDS WHEELCHAIR ACCESSIBLE?

Yes they are but please note some sites would require assistance. Please refer to the Event Coordinator for specifics regarding accessibility.

WHEN CAN WE COME TO DECORATE?

Please refer to your contract as all specific times are indicated. Ceremony décor can be done 1 hour prior to guest arrival and tabletop Reception décor can be done after 2:00pm on the day of your event. Professional decorators main gain access to the venue after 9:00am on the day of your event. Please refer to the BCC Event Coordinator for details.

WHEN DOES DÉCOR HAVE TO BE REMOVED?

Décor must be completely removed from the venue within 45 minutes of your allotted event end time as indicated on your contract. The BCC Team will work with professional decorators if they need an extend period to breakdown décor. But all décor must be removed the night of the event.

DOES BCC HAVE A FRIDGE TO STORE MY FLOWERS OR WEDDING CAKE?

No, BCC does not have a fridge to store flowers or wedding cakes.

ARE WE ABLE TO HAVE OUR PETS ON SITE?

Yes, pets are more than welcome to be part of your special day in any <u>outdoor</u> facility!

They must be well-behaved, be friendly, and remain on property at all times. They also must be cleaned up after if any mess occurs.
